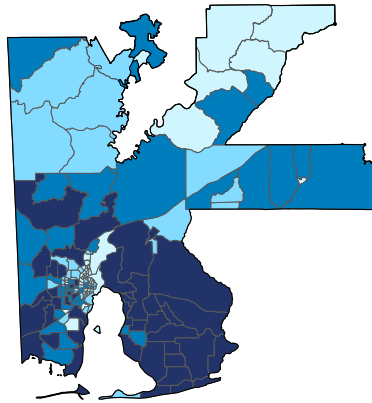

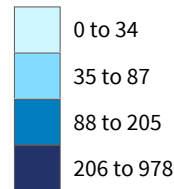

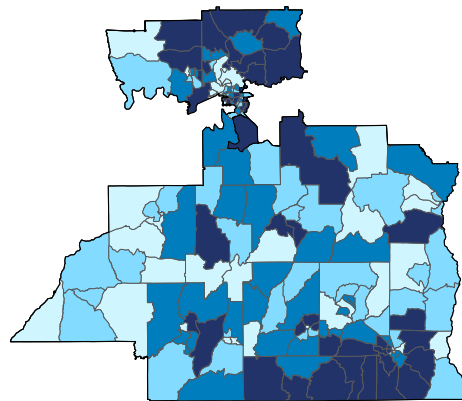
Alabama Congressional District 2



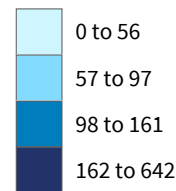

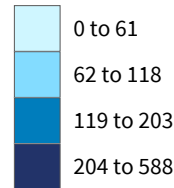

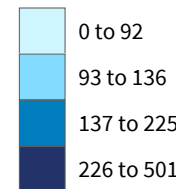

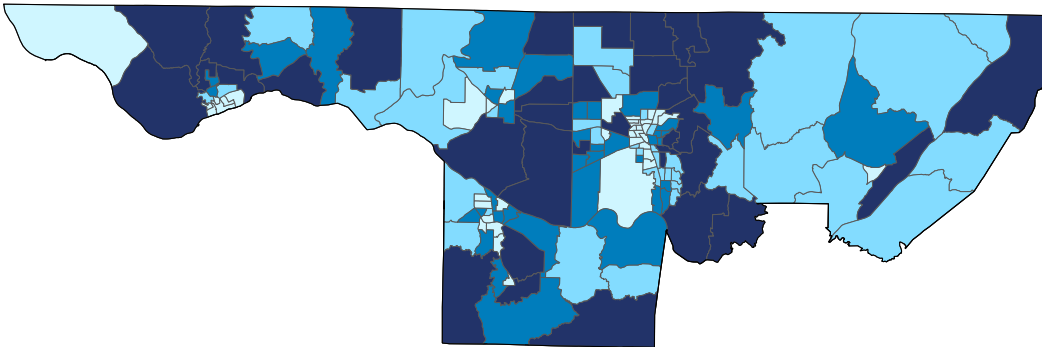
Alabama Congressional District 5



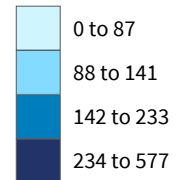

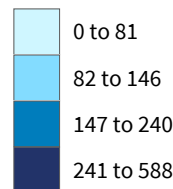

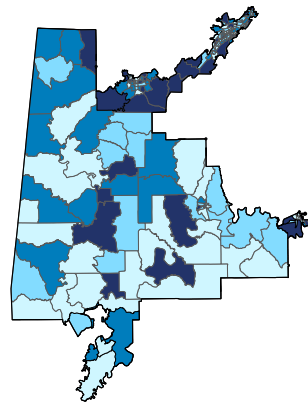
Alabama Congressional District 7



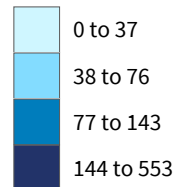
