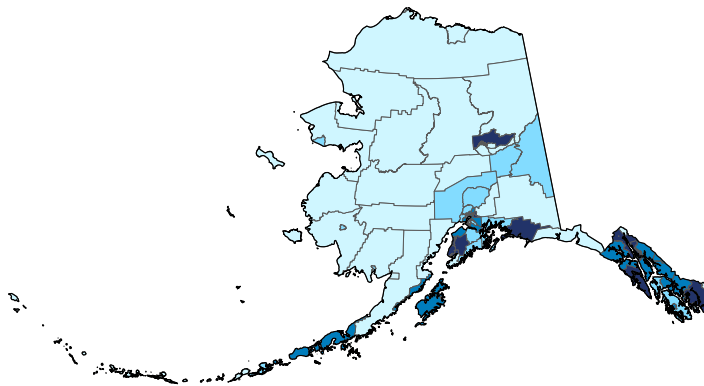
Alaska Congressional District



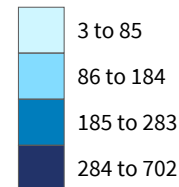
