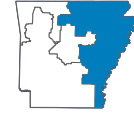

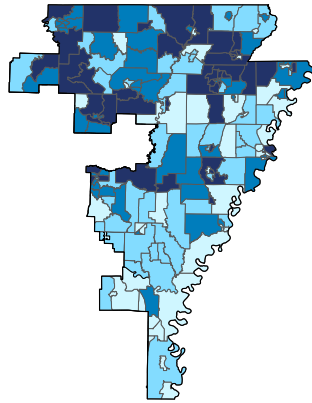
## Arkansas Congressional District 1



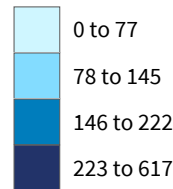

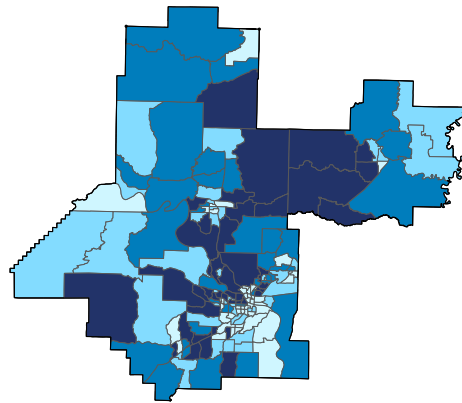

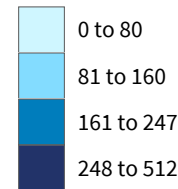

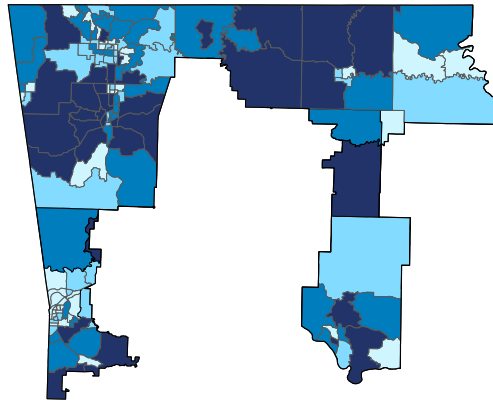

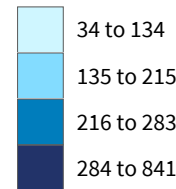

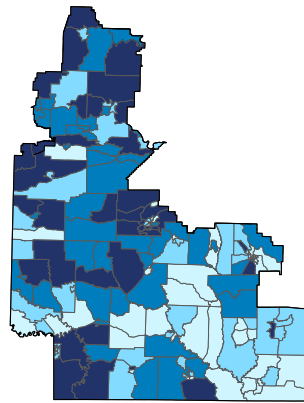

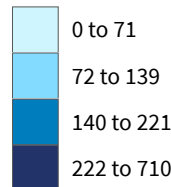
